

Reference: 1) Received application from Block Education Officer, Panchayat Samiti, Hatkanangale, dated 28/04/2023.
2) The sanctioned point by this office on 18/05/2023.

With reference to the above mentioned subject and your application. I, the Education Officer Primary, Zilla Parishad, Kolhapur Sanction the provisional permission to Sou. Vijayadevi Yadav English Medium School, Peth Vadgaon, Tal-Hatkanangale, (Permanently Non Grantable) for three years for the Grade 1 to 8 from 2022-2023 to 2024-2025. The school is granted temporary sanction under free and compulsory Education Act 2009, article 18 in promotion of free and compulsory Education Act 2011, Rule 11, Sub-Rule (4).

The above mentioned permission will be subjected to consummation of the following points:

- 1) The duration of the given permission will not be extended and will not be bound to give permission or affiliation after 8th Class at any circumstances.
- 2) The school will abide by the Right to Free and Compulsory Education to Children 2009 (Annexure 1) and Maharashtra Right to Free and Compulsory Education to Children Article 2011 (Annexure 2)
- 3) As per Para 3 bank account will be provided to school for such specified children under the Clause 12 (2) for reimbursement.
- 4) The School will not charge any Capitation Fee and will not force the child or his/her parent/guardian for any kind of admission scrutiny.
- 5) The school will not deny admission to the child stating the Clause of non-submission of the Birth Certificate, Religion, Caste, Race, Birthplace or else stating any of these reasons.
- 6) A) No child will be detained in the same class for the next Academic Year or cannot be expelled from the School till he/she completes the Primary Education.
B) No child will be physically punished or mentally tortured.
C) It is not mandatory to pass any Board Examination until the child completes Primary Education.
D) Every child who completed the Primary Education will be provided with a Certificate by Rule 23.
E) Differently Abled / Students with Special Needs will be considered as per the Provisional Rule.
F) Teachers will be appointed with minimum qualification and so in observance to the Article 23 (1). In accordance to the initial date or if any teacher does not hold the expected qualification, will have to complete his/her qualification within the span of minimum five years.
G) Teachers will accomplish his/her duty mentioned in article 24(1).
H) The school will affirm that teachers should not get involved into Private Tuitions.

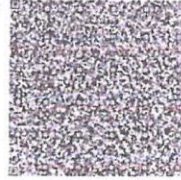

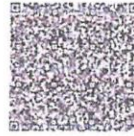
